The Approach

What was the scope of their involvement?

Initially, we thought that we needed to process 36 states which would've cost us a lot of money. However, Matthew (Director of Business Development) explained the requirements to us and told us we only needed to process 12 states. He showed us the chart of the requirements for each state.

He also walked us through what we needed to do on the forms so they could be uploaded to the state websites. We followed his recommendation, and he reviewed what we did in the file. Then, he sent us corrections the same day. A day after, he sent 1099 forms to the various states, and then we got confirmation that everything was uploaded and done on April 26, 2021.

There were also state identifications (IDs) that we needed to file. I knew our New Jersey ID, but I was unaware that we had one in Pennsylvania. Matthew just told us about it. He then called Pennsylvania for us and got the ID for us.

We only worked with Matthew.
